A. Planning Calendar for Adoption of the Budget and Tax Rate for the 2018-19 School Year

The Planning Calendar for Adoption of Budget and Tax Rate provided for public meeting on August 21, 2018 with adoption of budget and tax rate on August 28, 2018. A motion was made by Gerald Lopez and seconded by Katie Reed to approve the Planning Calendar as presented. Motion carried unanimously.

B. Notice of Public Meeting to Discuss Budget and Proposed Tax Rate

The Board is required to provide for the publication of the Notice of Public Meeting to Discuss Budget and Proposed Tax Rate. The proposed tax rate must be presented in two separate components: Maintenance and Operations (M&O) Rate and Interest & Sinking (Debt) Rate. The tax rate that is adopted for the year 2018 may not exceed the proposed rate of \$1.375500 (M&O rate - \$1.040000; I&S rate - \$0.335500) shown in the notice unless the District publishes a higher proposed tax rate in a revised notice and holds another public meeting to discuss the second notice. A motion was made by Gerald Lopez and seconded by Katie Reed to approve the notice of public meeting to discuss budget and proposed tax rate as presented. Motion carried unanimously.
